PREPARATION:

SUBSTRATES SHOULD BE SOUND, CLEAN AND FREE FROM DIRT, DUST, OIL, ETC AND MUST BE TOTALLY DRY. WE RECOMMEND CLEANING WITH NEXUS PAVING & DRIVEWAY CLEANER PRIOR TO APPLICATION AND LEAVE TO DRY FOR AT LEAST TWO DAYS. IT IS VERY IMPORTANT THAT THE PAVING IS LEFT TO ALLOW ALL MOISTURE WITHIN THE PAVING TO DISAPPEAR. PROJOINT PRO810 INVISIBLE SEALER IS DESIGNED AS AN INVISIBLE COATING BUT MAY DARKEN VERY LIGHT SURFACES SLIGHTLY. AS WITH ALL SEALANTS, TEST ON A SMALL INCONSPICUOUS AREA BEFORE FULL APPLICATION. THE SEALER IS SUPPLIED READY FOR USE AND SHOULD BE APPLIED WHEN THE SURFACE TEMPERATURE OF THE PAVING IS BETWEEN 5°C AND 25°C. AS A GUIDE, THE STONE SHOULD BE COOL TO THE TOUCH.


